### PRODUCT DESCRIPTION

Reinforcing steel is encased in concrete in order to improve the tensile strength of the latter in structures bearing axial or bending loads. The steel is relatively simple and comprises about 99 % iron.

The reinforcing-steel products consist of bars, mesh, cut-to-length and bent pieces starting from bars in long length or coil supplied from a steel plant. The bar surface is often ribbed in order to facilitate bonding between steel and concrete. The cut and bent parts can be of standard shape or bespoke in accord with drawings supplied by a construction company. In many instances, parts are welded or otherwise joined together to form more complex cage arrangements tailored to the final construction.

The finished parts are packed and delivered to the construction site ready to have concrete poured around them. Steel reinforcing will normally last over the life of the concrete structure. It is 100 % recyclable in the event that the structure is demolished.

### MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The environmental impacts considered for the product stage encompass the manufacturing of raw materials used in production, as well as packaging materials and other ancillary materials. Additionally, this stage includes the fuels used by machines and the handling of waste generated during the production processes at the manufacturing facilities. The study also accounts for material losses occurring during the manufacturing processes, as well as losses during electricity transmission.

Tibnor purchase reinforcement products from several suppliers (A1). The exact allocation of volume between suppliers varies over the years depending on availability and cost. The reinforcement products are delivered to Köping (A2) where they can be cut-to-length and bent according to the customers wishes and requirements or delivered to the customer in standard stock lengths (A3). Some reinforcement products are delivered directly from the supplier to the customer. The transport from suppliers is done by train, ship, and/or in some cases by truck, the products are always bundled, sometimes with steel wires from the mills. When sent to customers from Tibnor's site the products are either bundled or also secured with steel strip and clips, if cut in short pieces EU pallets can be used. Electricity used at the site is climate neutral fossil free electricity, waste from production is steel scrap (A3).

### TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

Transportation impacts from delivering final products to the construction site (A4) include direct exhaust emissions from fuel, environmental impacts of fuel production, and emissions related to the associated infrastructure.

The transportation process in module A4 comprises impacts from transportation of the products from Tibnor's Warehouses to the customer in Sweden.

Delivery to customer site either is directly from our supplier or from Tibnor's warehouse (A4). Transportation from Tibnor's warehouse is done by truck (Euro 6). Vehicle capacity utilization is at least 70% A5 is excluded.

### **PRODUCT USE AND MAINTENANCE (B1-B7)**

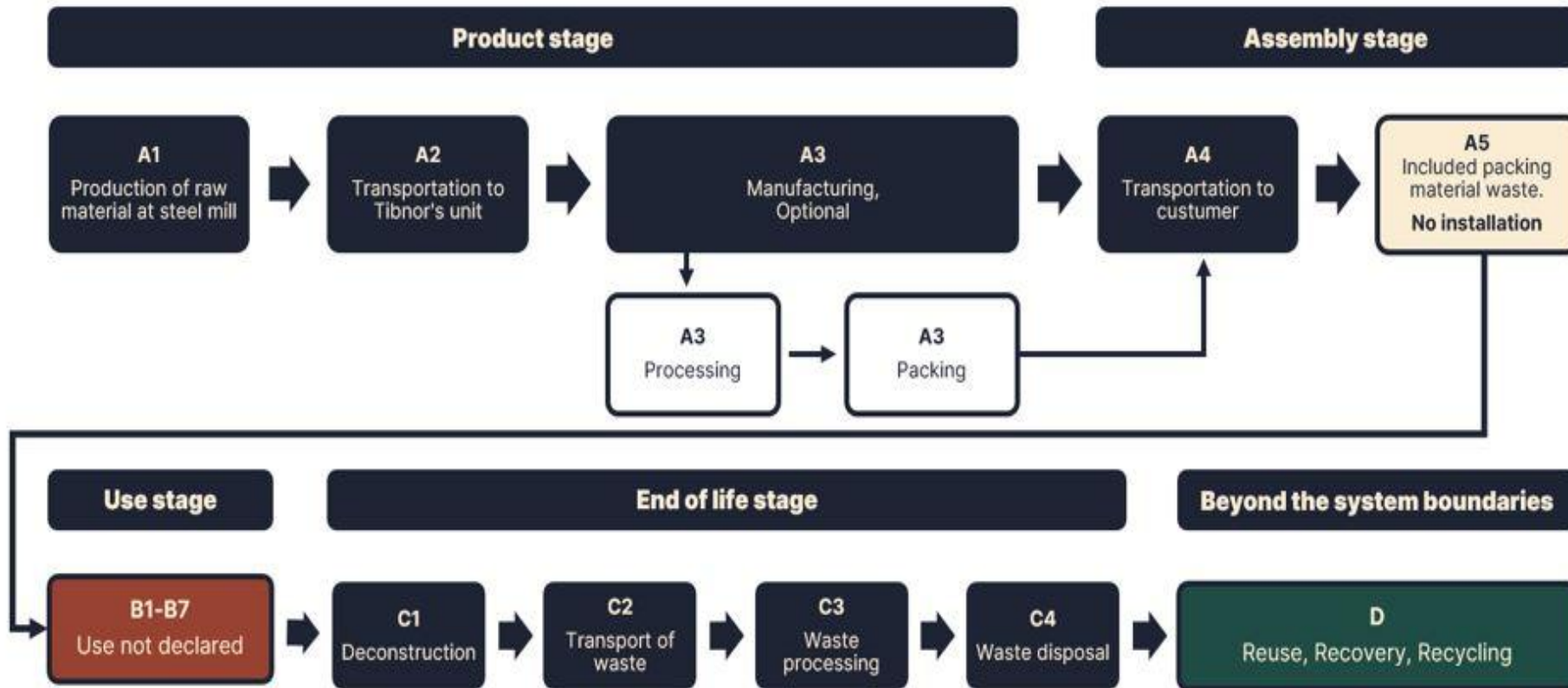
This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

### **PRODUCT END OF LIFE (C1-C4, D)**

Demolition is assumed to consume 0,01 kWh/kg of product. The source of energy is diesel fuel used by construction machines (C1). It is assumed that 100% of the waste is collected and transported to the waste treatment center. Transportation distance to treatment is assumed as 20 km and the transportation method is assumed to be truck (C2). Approximately 99% of steel (hot rolled) is assumed to be recycled (C3). It is assumed that the remaining 1% taken to landfill for final disposal (C4). Due to the recycling process, the end-of-life product is converted into recycled steel, while the wooden pallet is incinerated for energy recovery (D)

# LIFE-CYCLE ASSESSMENT

## CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.
